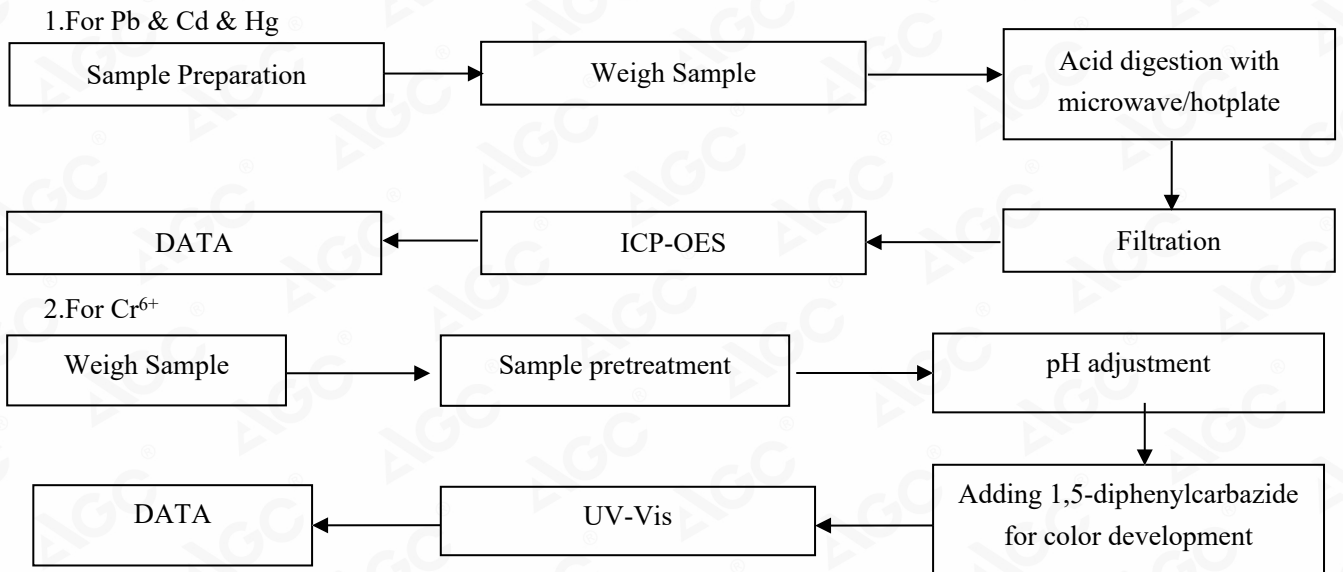

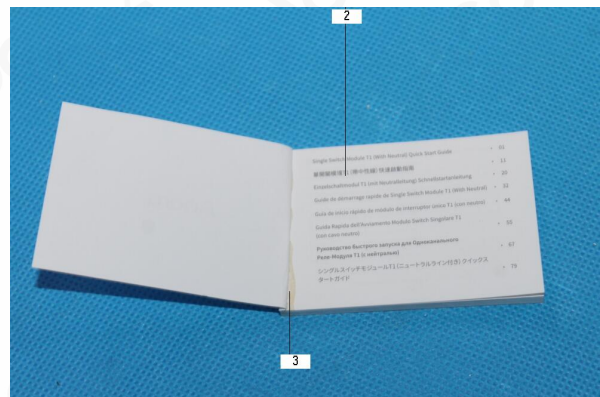
### Test Flow Chart

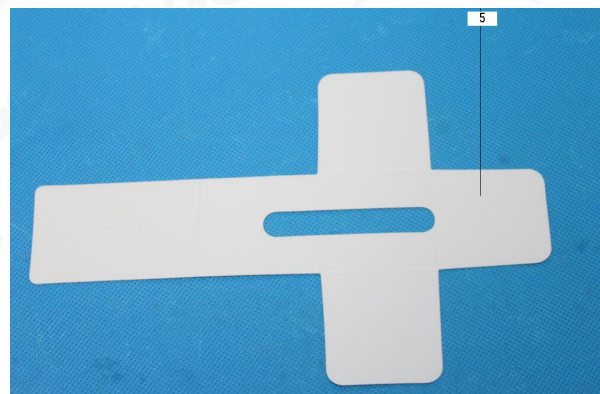
