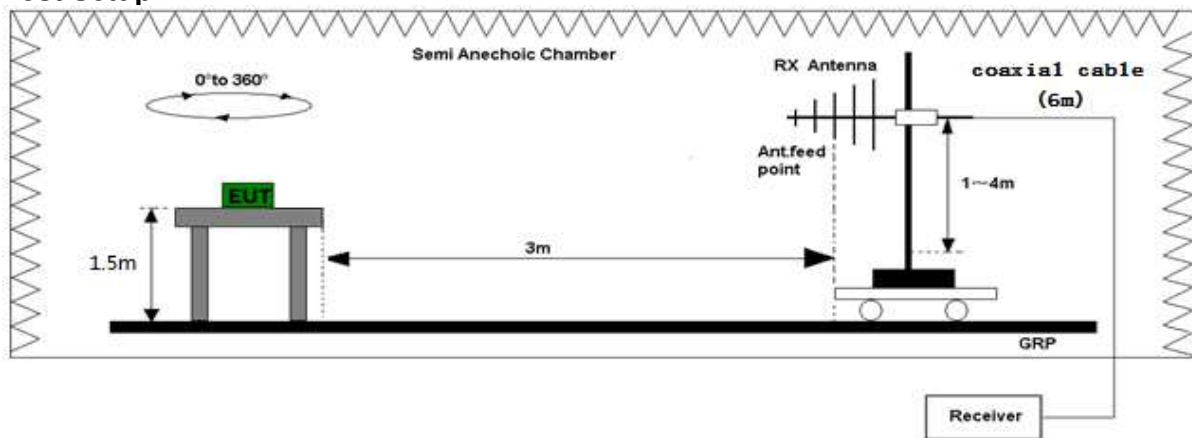

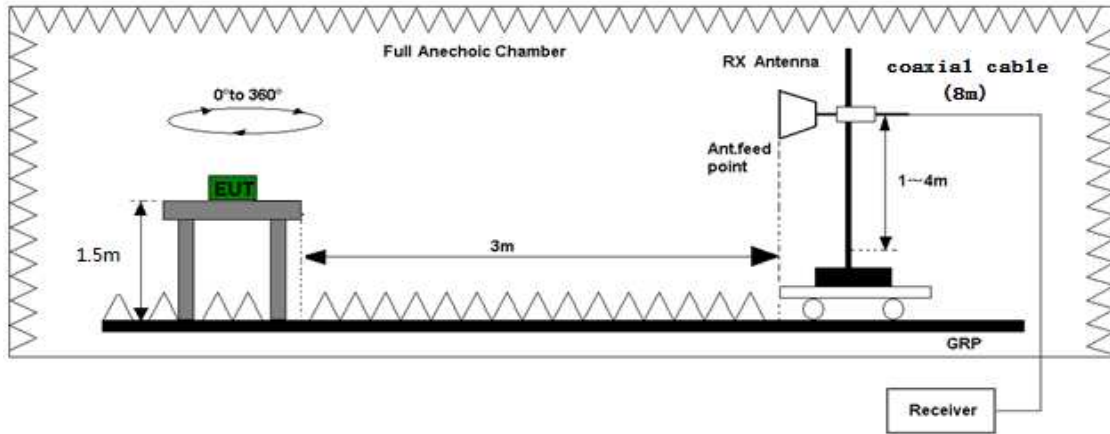

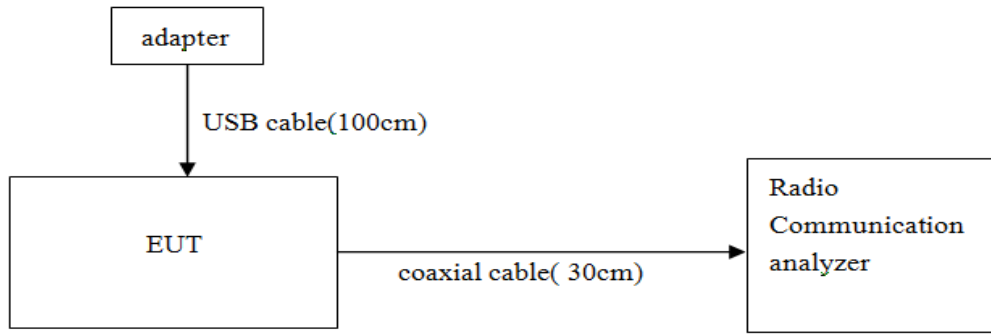


Radiated spurious emissions(30MHz-1GHz)

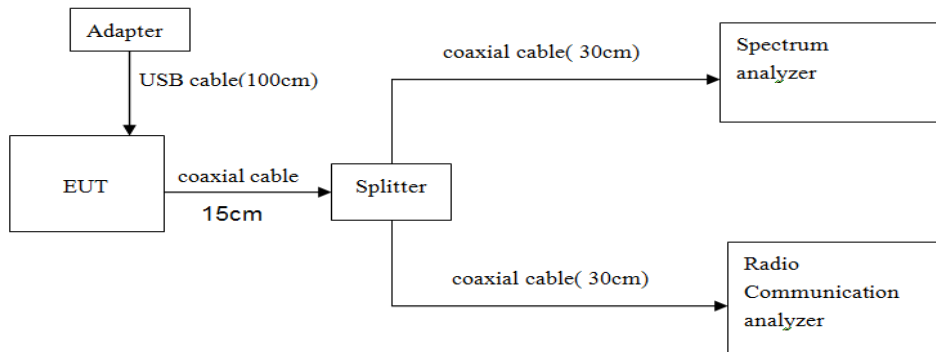




Radiated spurious emissions(Above 1G)

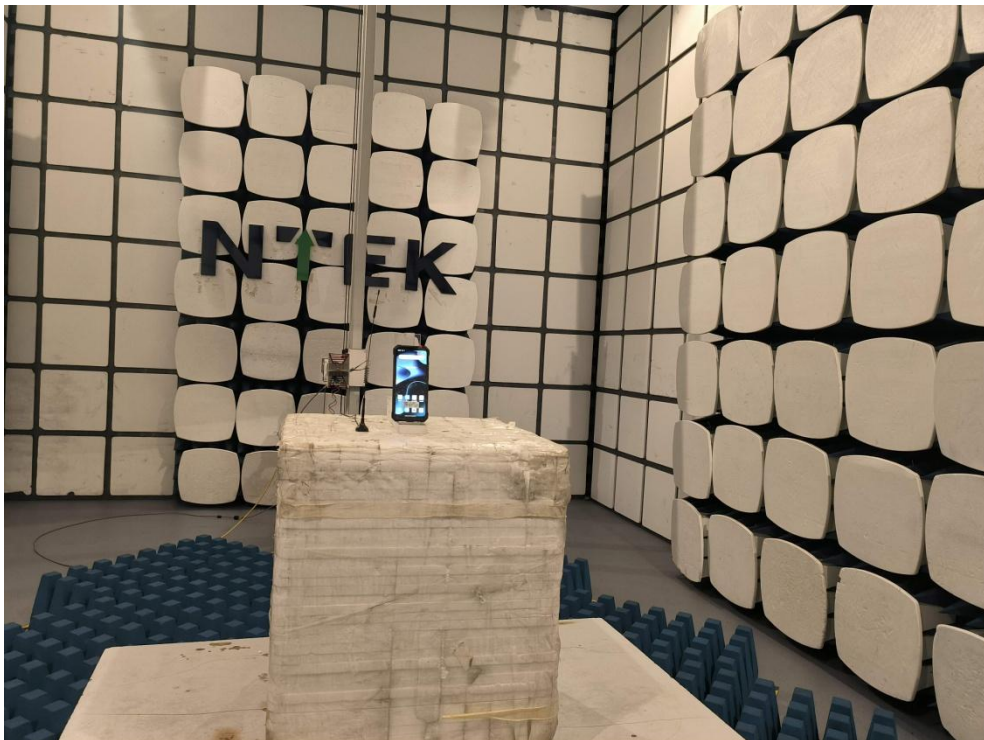
