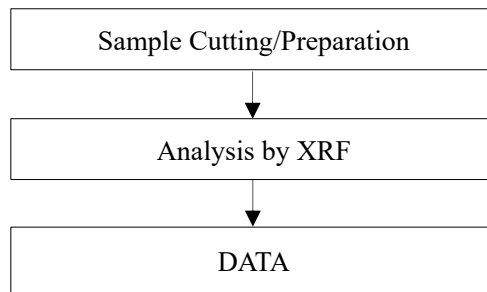

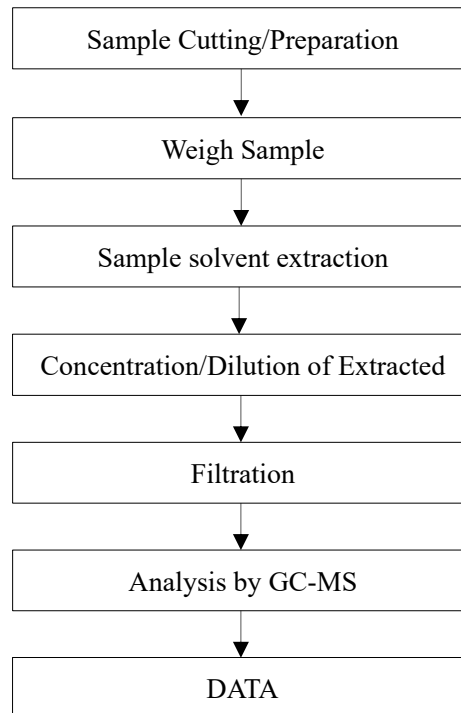

### Test Flow Chart of Phthalates



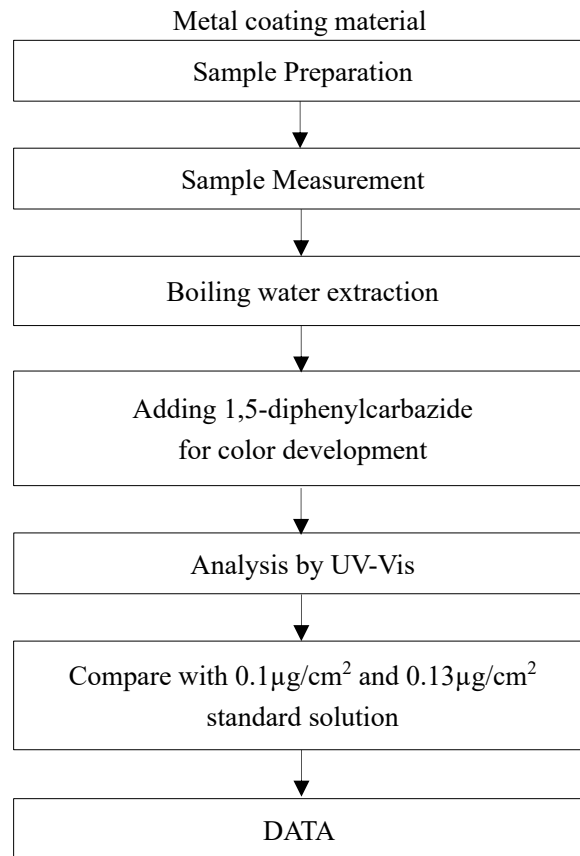

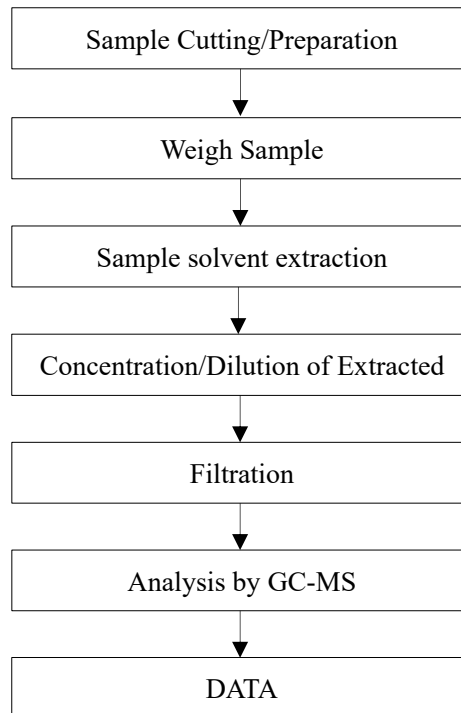

**Test Flow Chart of PBBs and PBDEs**

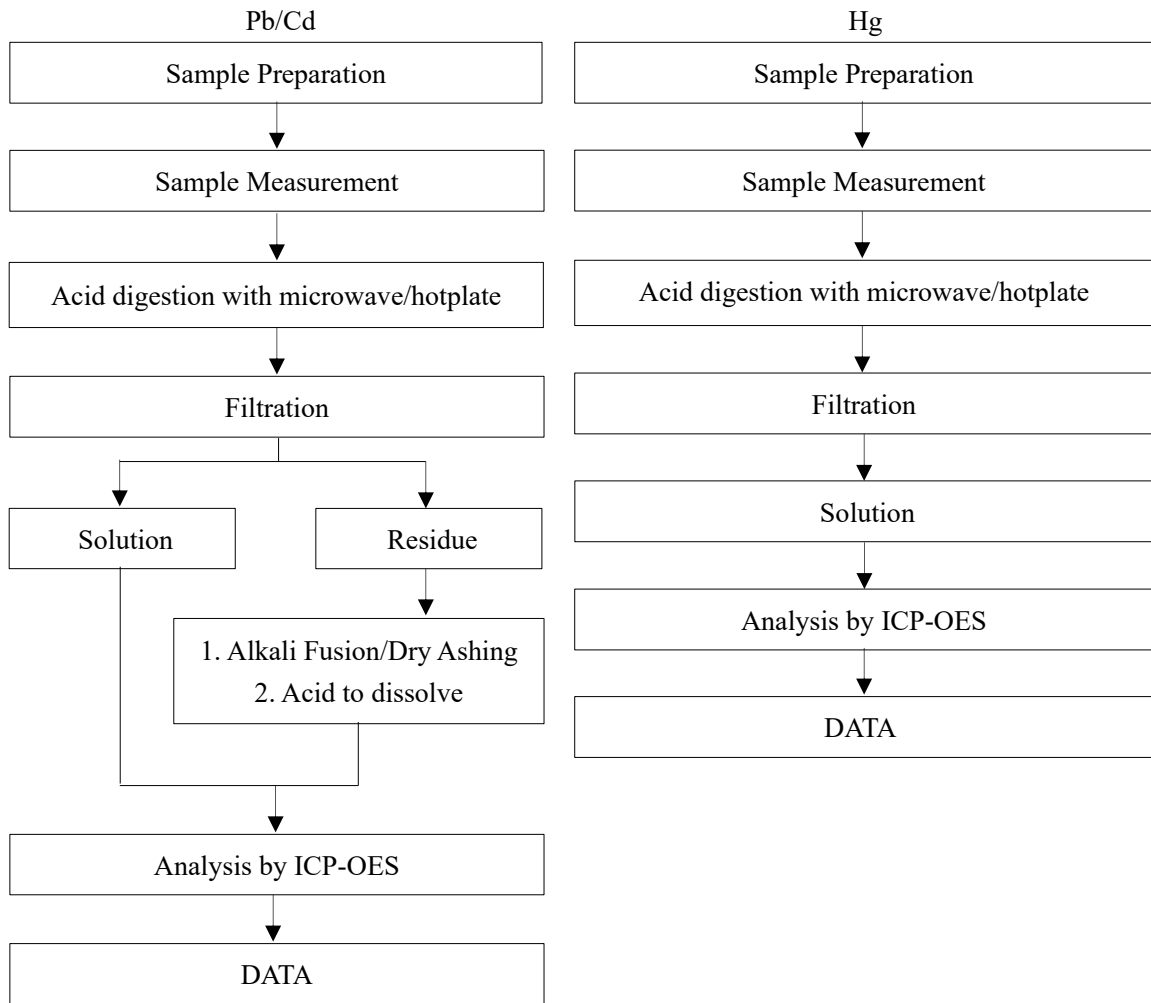

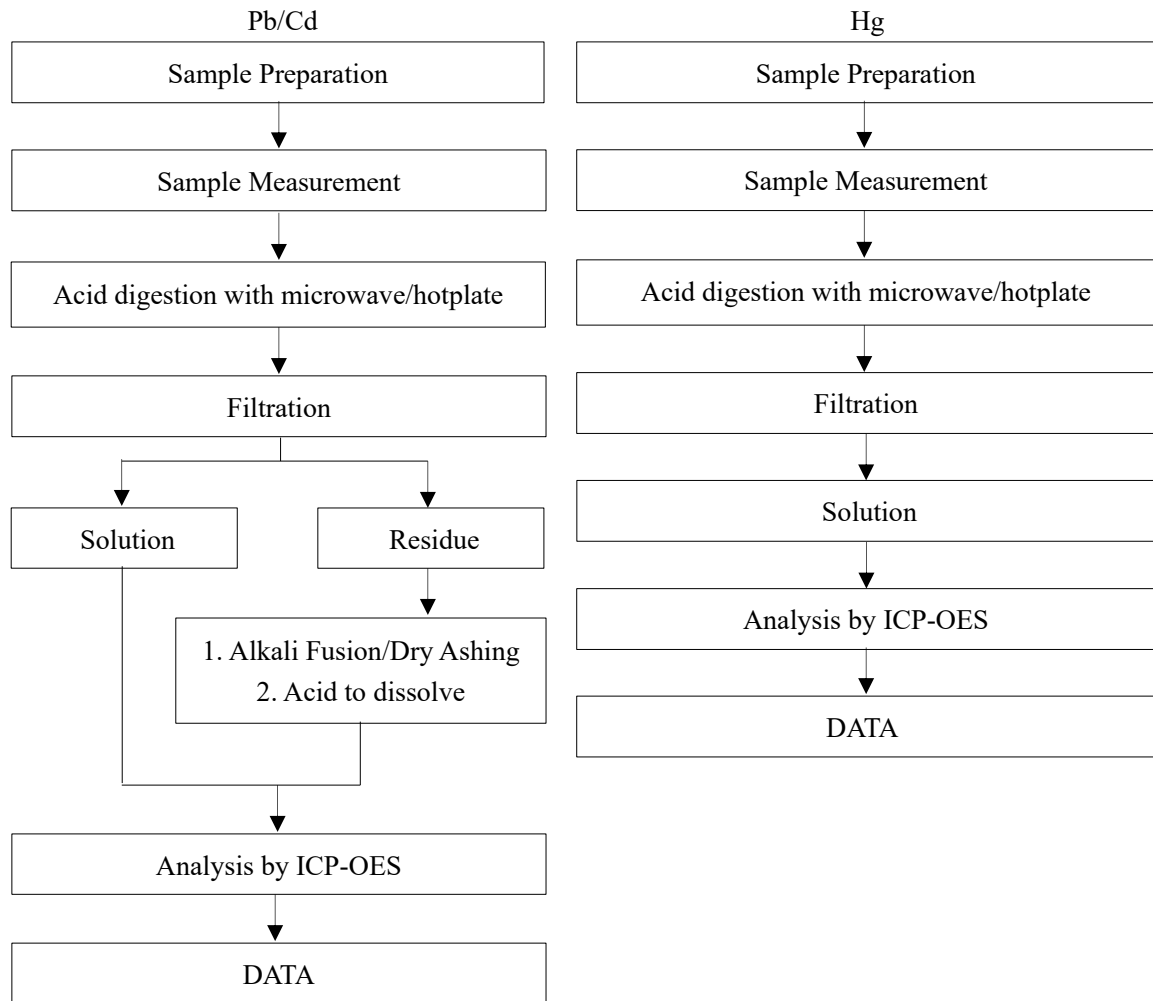
**Test Flow Chart of Lead, Cadmium and Mercury**
