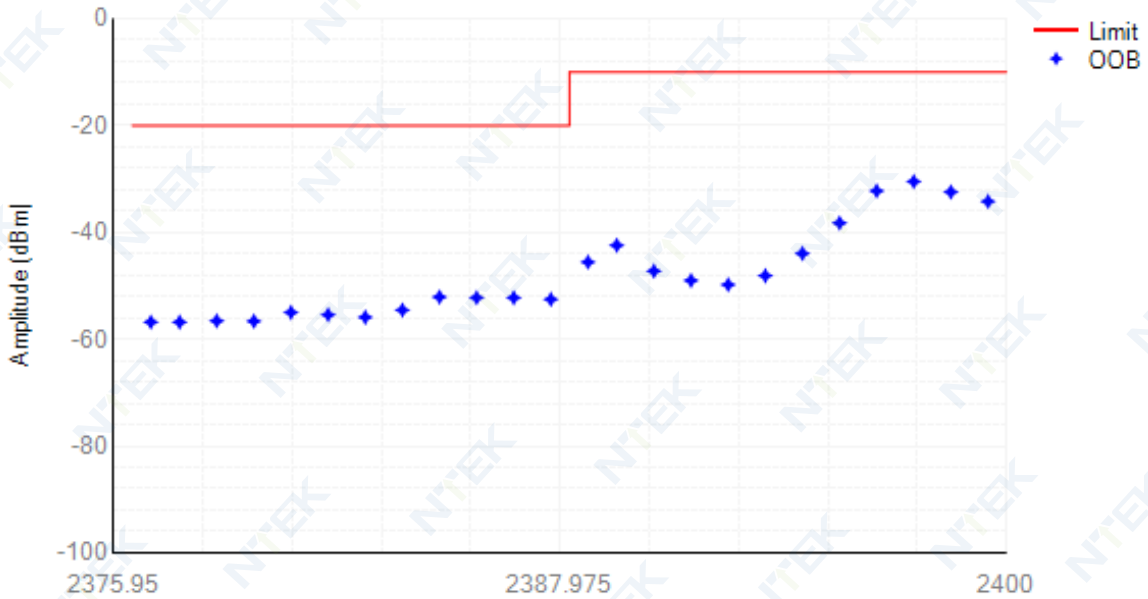

Transmitter unwanted emissions in the out-of-band domain

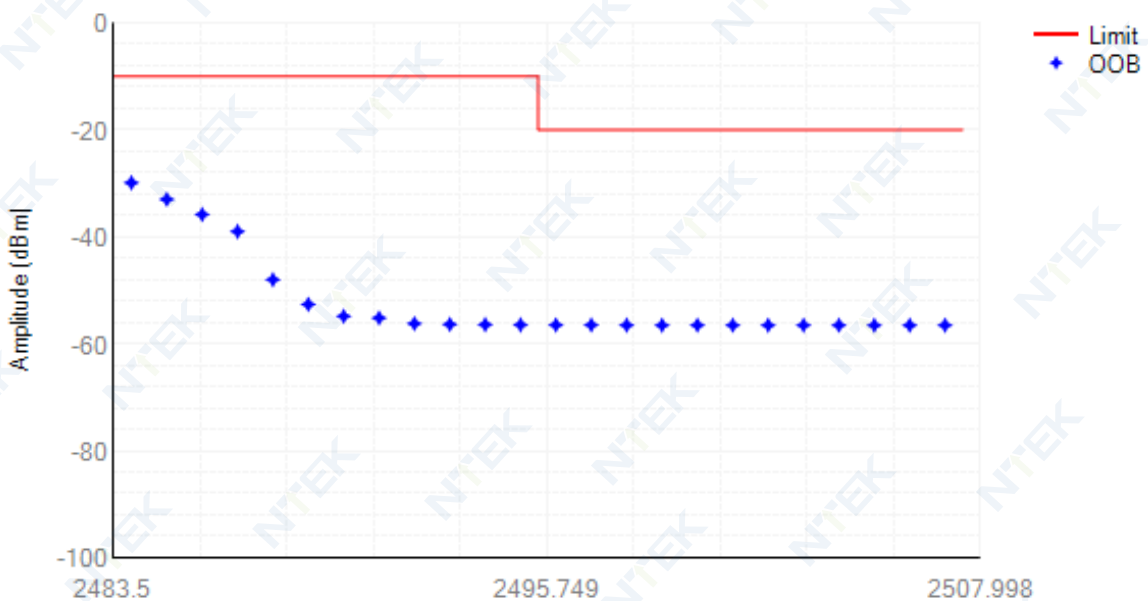

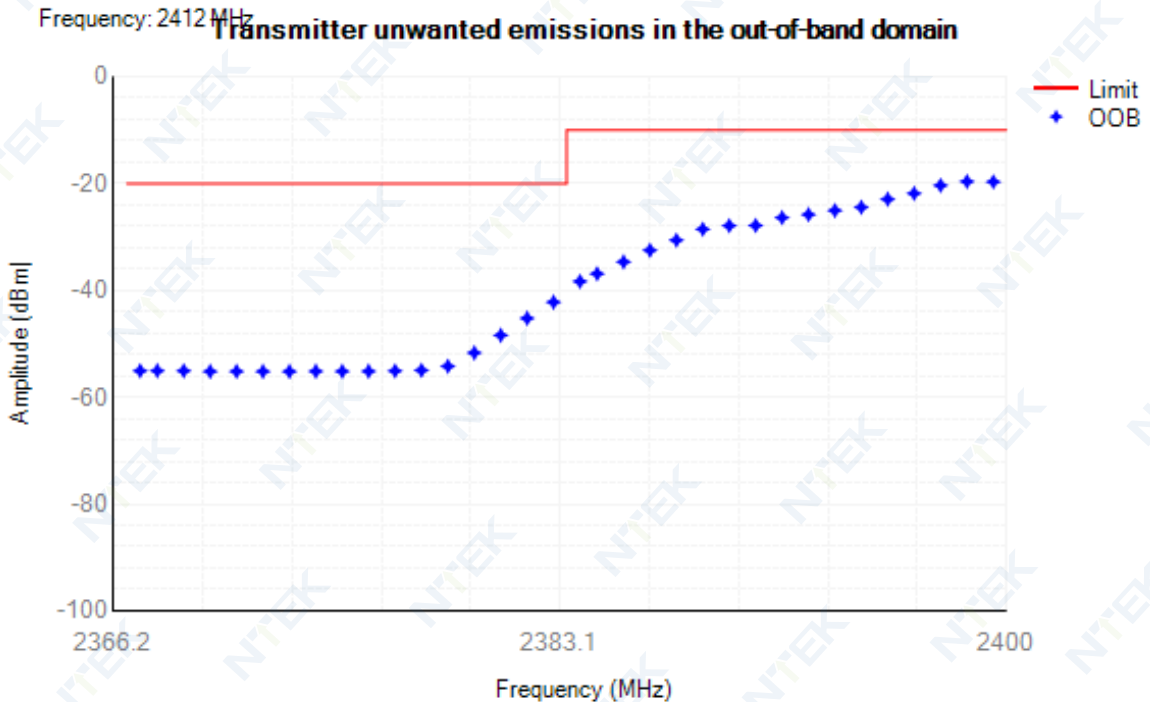

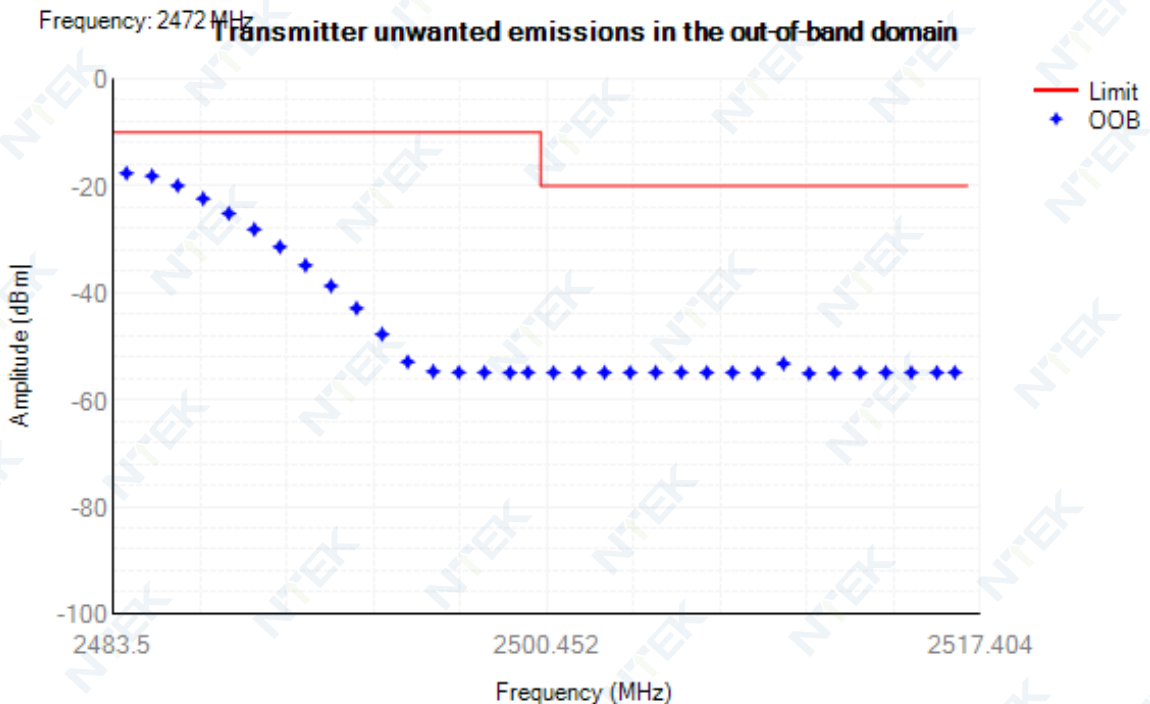

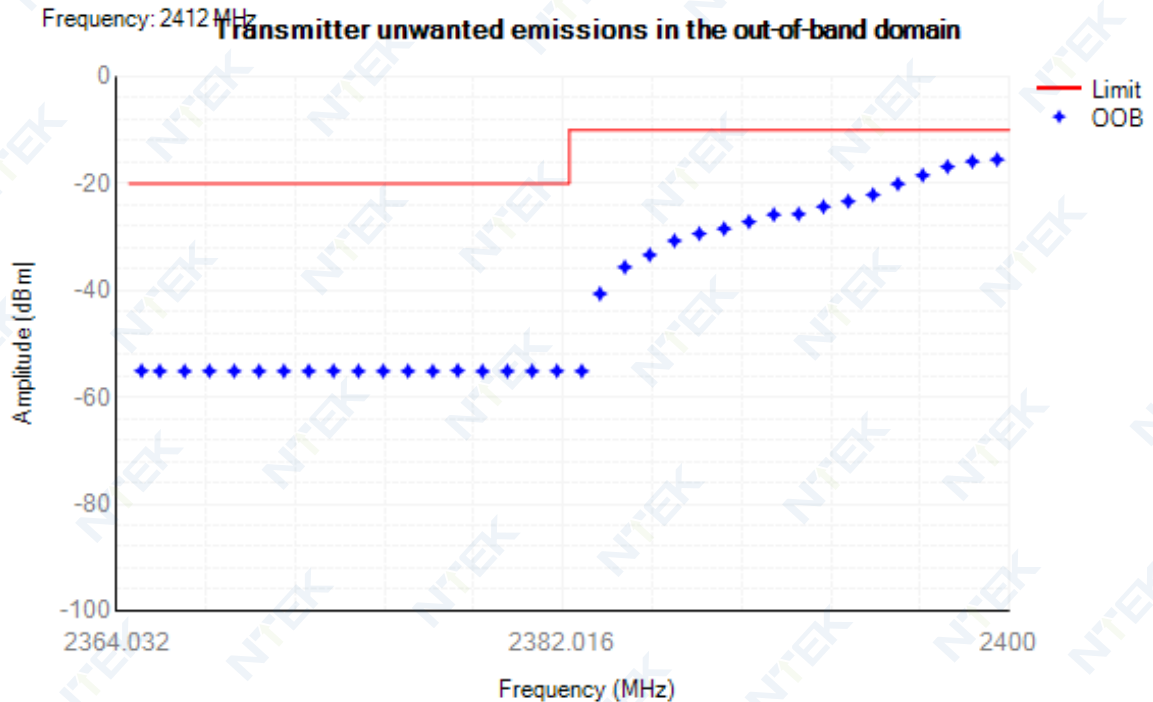

Tx. Emissions OOB NVNT g 2472MHz Ant1



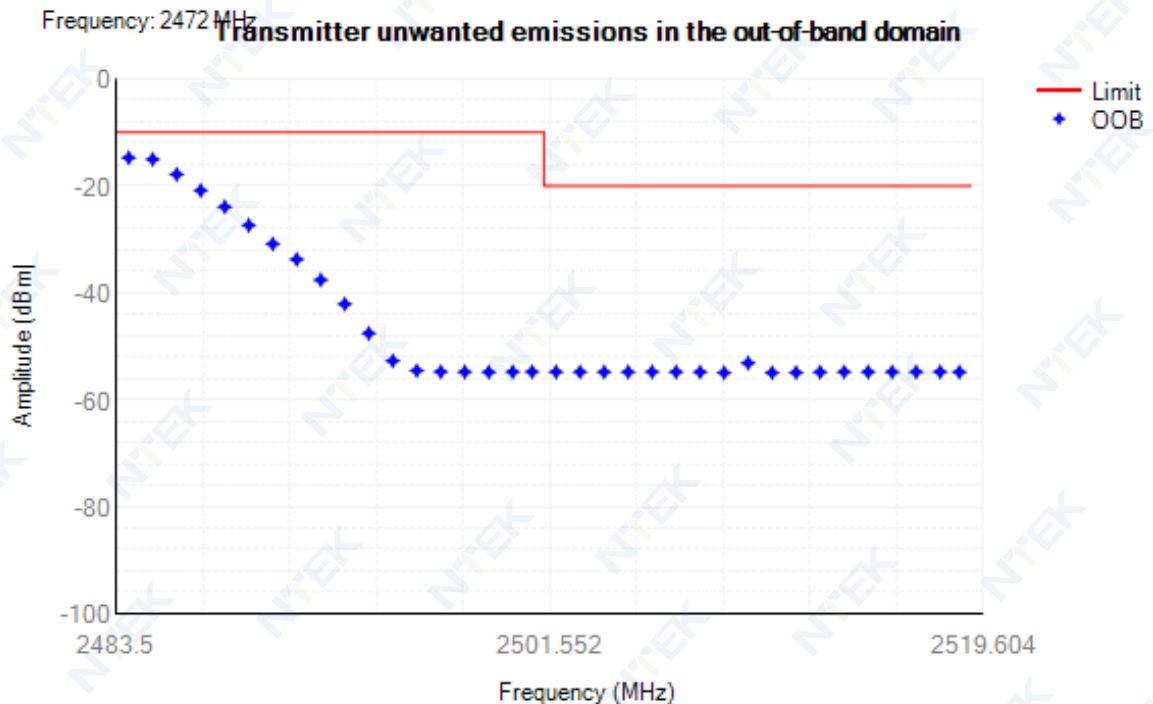

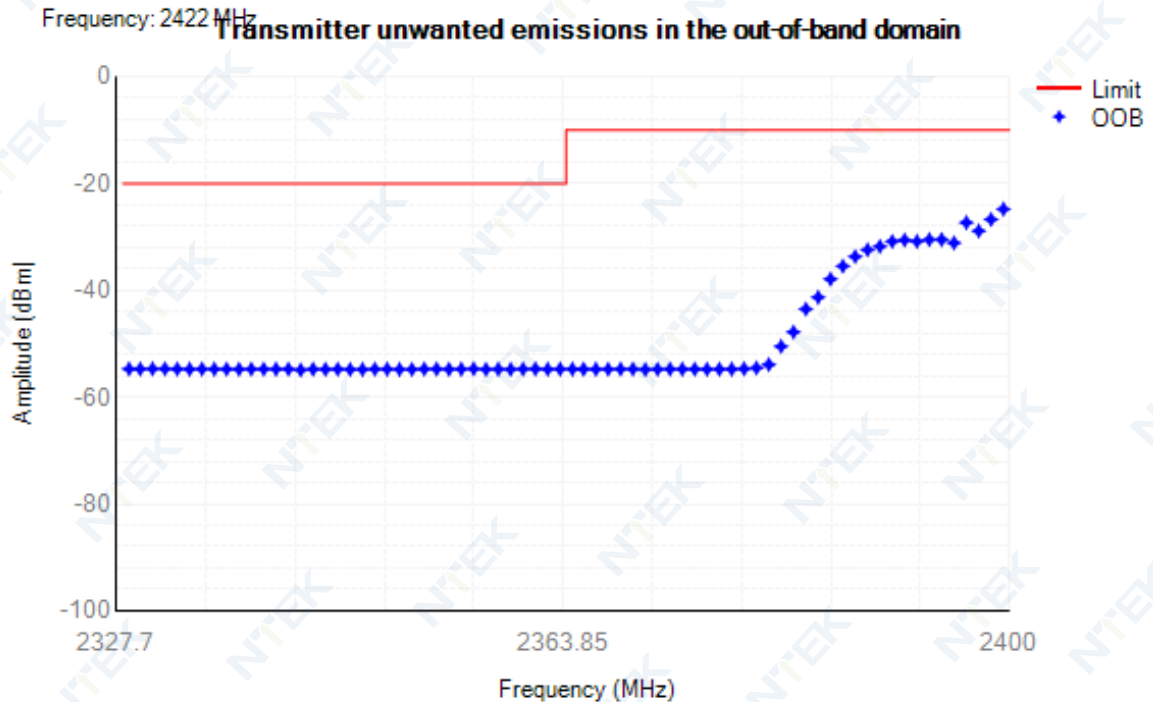

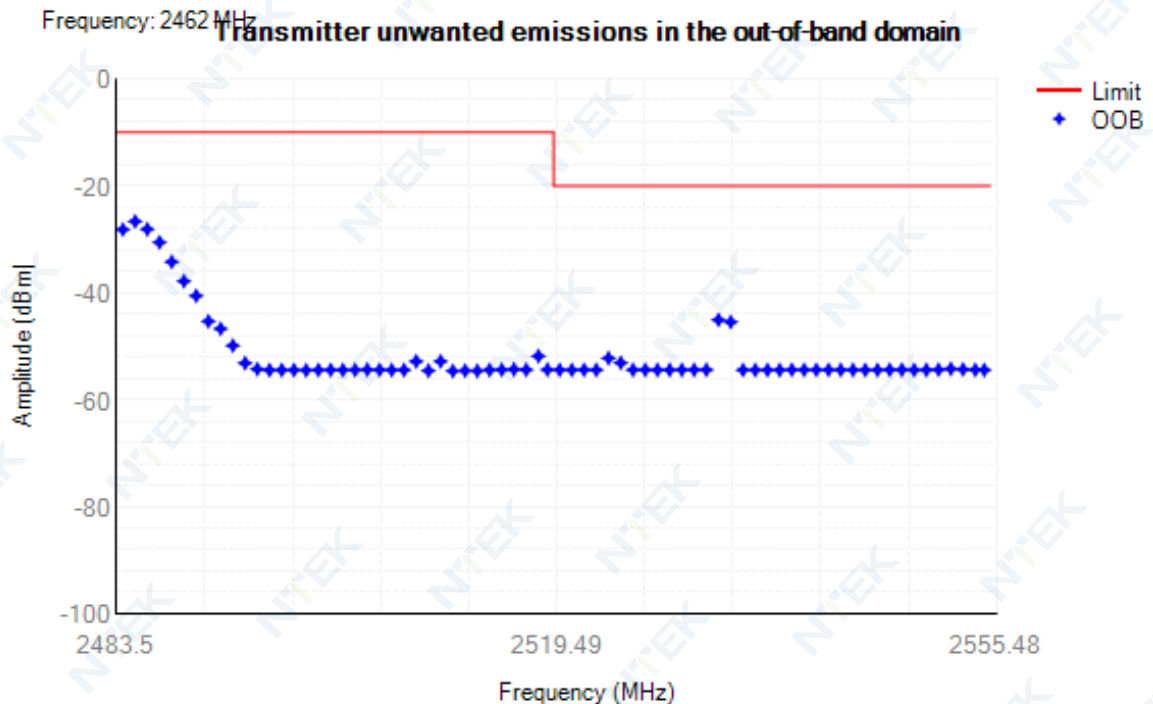
