

### 3. TEST RESULT

The maximum output power of Bluetooth is **BR/EDR 5.76dBm (3.76mW which is less than 20mW)**. Please refer to ETSI EN 300 328 (V2.2.2) Test report (AGC10798220201EE04) for the result of Maximum Transmit Power, which deemed to comply with the basic restrictions without testing.
